



QUALITY AND SAFETY POLICY

The Pienne Impianti S.r.I., in the context of their development strategies, has considered that the guarantees of quality and safety must be integral and fundamental part of the business mission in order to get both an inside growth and a strategic development in line with the times. - manage the processes and the related activities in order to assure the continuous improvement through the definitions of objectives and targets, coherently with the activities and the programs of development of the company;
- achieve the maximum integration with our suppliers, in order to offer an adequate and long-term service to the customer;
- inform, form and educate all the staff to the current regulations in force in the field of security;
- monitor and manage with appropriate corrective actions the non-conformity, in order to document the actual business push to the long-term improvement;
- provide all the staff of the instrument to manage their business and inform and teach them, in relation to specific tasks, business on the objectives and the means and instruments available for their achievement;
- respect the legislation in force, and any requirements if real and legitimate, of anyone in territorial context can be directly affected by business.

The Directorate has been taken in the first person the honor of pursuing these objectives entrusting the practical implementation to all the operating staff, properly motivates and sensitized, and exercising the continuous monitoring of compliance, as established through the function of quality and safety managers and the periodic reviews of effectiveness and efficiency of the integrated and implemented system.

In particular RGP (Quality Manager) and RSPP (Safety Manager) have the authority to intervene in any company business relating to production and control, in order to verify that the benefits are consistent with the specifications of the customer and to the aims of quality and safety.

The present policy is brought to knowledge of all the staff in order to obtain a total involvement of theirs in pursuing the quality objectives of the company, as well as of the strategic suppliers.

The present policy is annually re-examined on the basis of the results of the quality system for the validation and revision of the objectives and the goals of improvement.
